3- Framework and objectives of the training

A- Enrolment requirements

- This Master's program is open to holders of a Bachelor's degree in Public Law L.M.D.
- Holders of a classic system Bachelor's degree are eligible to enroll in the corresponding Master's program.
- Admission to this Master's program is based on the conditions and standards set by the Faculty's Ranking and Orientation Committee.

B- Program Objectives

This Master's program is research-oriented and aims to train professors and researchers in the field of modern methods or mechanisms of state intervention in the economic sector, mainly through the development of legal provisions and the competent administrative authorities in the field of market regulation and control.

This Master's program also offers scales that can be taught simultaneously in public and private law, allowing students to acquire a broad education and, ultimately, knowledge that extends beyond their area of expertise. We also note that this Master prepares students to address the theories and concepts that unite various stakeholders in economic life (national or international institutions, local collectivities, public administrations).

C- Targeted Qualifications and Skills

The Public Economic Law specialization trains specialists in the field of economic law, including lawyers and legal advisors in this area.

This Master's degree also prepares students for entry into the business world and will allow them to obtain advanced qualifications in the field of economic law.

The seminars scheduled during the training phase also allow students to focus on issues related to the protection of foreign direct investment and banking techniques, applying the basic theories acquired during the training phase.

Through this Master's degree, students will also be able to master the law relating to public transactions and the delegation of public services as a means of rationalizing and optimizing public spending. We also note that the Consumer Protection law and the Industrial Property law complement this theoretical approach.

The Master's project in Economic Regulation Law opens up opportunities for collaboration between the university and the fields of business and public administration.
