- ✓ The program aims to prepare specialists capable of providing fatwas on societal issues and participating in Sharia boards, whether those related to Sharia oversight in Islamic banks or those that provide Sharia consultations related to public affairs.
- ✓ aims to prepare cadres capable of teaching and conducting scientific research in the field of Islamic Sharia.

✓ Curriculum Highlights

Duration: The training period extends to two years, each year divided into two semesters. In the first three semesters, the student studies a set of theoretical subjects, each divided into the following educational units: the basic education unit, the methodological education unit, the exploratory education unit, and the horizontal education unit. The last semester (the second of the second year) is dedicated to the student completing the graduation thesis.

✓ Admission Requirements

Enrollment in the program requires meeting the following conditions:

- ✓ Baccalaureate certificate (or its international equivalent).
- \checkmark Bachelor's degree (Licence degree or its equivalent) in a relevant specialization.
